

2021 OFWC CONVENTION

Can I Vote?

Am I a Delegate

Or Delegate-at-Large?

Clubwomen attending the State Convention are participating in the yearly business meeting of the GFWC/Ohio Federation of Women's Clubs. Each club has at least one vote on the issues that are presented before the assembly. Know if you are a delegate or a delegate-at-large and may vote.

DELEGATES

1. Each per capita club of 25 members or less is entitled to ONE delegate (or her alternate).
2. Each per capita club of 26-50 members is entitled to TWO delegates (or their alternates).
3. Each per capita club of 51-75 members is entitled to THREE delegates (or their alternates).
4. Clubs with more than 75 members are entitled to ONE delegate for each additional 50 members up to a membership of 1,200.
5. Direct members may meet at each Convention and elect ONE delegate who is also a Direct Member to represent them.
6. Each City-County Federation of 10 clubs or less is entitled to TWO delegates and ONE additional delegate for every 20 additional member clubs.

DELEGATES-AT-LARGE

1. OFWC Board of Directors and Junior Board.
2. Those members having served in ELECTIVE offices at state or district level.
3. Officers and chairmen of GFWC residing in Ohio.
4. ALL CURRENT State and District Community Service Program chairmen.
5. ALL members of Standing and Special Committees.
6. Trustees of all funds and *The Buckeye* staff.

NOTE: It is possible that members are in both categories, but only one vote per member is allowed. Have clubs decide before registering who will be the club delegate and vote the club's wishes.

*If you are not a delegate or delegate-at-large, you will check the "Non-Voting Member" line on the registration form.



The Ohio Memorial Forest and Shrine

Are you a calligrapher or do you know someone who is? We need someone to add the names of the four most recent casualties to the Great Books housed in the Ohio Memorial Shrine. The Shrine trustees are also in the process of reviewing all Ohio brothers and sisters who have made the ultimate sacrifice to make sure their entries in the Great Books are in the proper places and their names are easily found by family and friends.

If you have never visited the official Ohio Shrine, please try to attend our next Gold Star Mother's Pilgrimage and Memorial. It will be September 26, 2021 on the day commemorated as Gold Star Mother's and Family's Day.

Members of the GFWC Ohio Federation of Women's Clubs from throughout the state raised the money, in two years, to build the Shrine, which was dedicated on April 27, 1947. Inside the Shrine are two "Great Books" inscribed (in calligraphy) with the names of individuals who made the supreme sacrifice not only in World War II, but also in the Korean War, the Vietnam Conflict, Persian Gulf War and the Wars in Afghanistan and Iraq.

Over the years, state foresters from the Ohio Department of Natural Resources (ODNR) have planted more than 310,000 trees in the area as living memorials to the over 20,000 Ohio war dead honored within the Shrine. In 2008 the "Memorial Walkway" was unveiled, and the newer "Friends Walkway" was dedicated in 2009. Both walkways are constructed of Ohio made bricks and pavers purchased through members of the GFWC Ohio Federation of Women's Clubs with donations and/or engraving of the bricks or pavers. Those wanting to honor or memorialize someone can order standard size bricks with up to three lines of letters or larger pavers up to the size of four bricks with graphics and letters, other sizes are also available. We now have a new engraver, and more options are available.

Please send the design and lettering to the Paver chairman so she can make sure it is doable from the engraver and if there will be an additional cost. After notification you will send your check to GFWC Ohio Treasurer (Deidra Devore). Rose Logston serves as state chairmen of the Bricks and Pavers Committee and Ohio Memorial Shrine Trustee Chairman.

The GFWC Ohio Pioneer Workers

The Pioneer Workers of the Ohio Federation of Women's Clubs united on October 16, 1912, in Athens, Ohio, during the 17th annual convention. Twenty women, consisting of Founders (Pioneers - women who had served as officers, club presidents or delegates at the OFWC organizational meeting at Springfield in October 1894), chairmen of standing committees, presidents and delegates of Federated Clubs who participated in the convention prior to and including 1900, were enrolled at that meeting.

The purpose of this union was to strengthen the bond among the early workers of this great organization and this union continues today with your membership in the GFWC Ohio Pioneer Workers.

Officers and members of the GFWC Ohio Federation of Women's Clubs Board of Directors, all chairmen of community service programs, standing committees, *The Buckeye Magazine* staff and trustees of the scholarship funds and the Memorial Forest who have served a full two-year term on the state level are eligible for membership.

2021 PIONEER WORKERS BY-LAW CHANGES

Current: ARTICLE V - OFFICERS

Section 1. The officers shall be a president, a vice president, and a secretary-treasurer, all of whom shall be elected biennially by ballot in the same year (even numbered years) that the officers of GFWC/Ohio Federation of Women's Clubs are elected. They shall serve for two (2) years or until their successors are elected. If there is but one nominee for each office, the election may be by voice.

Proposed Change: Section 1.: first sentence insert “ballot”: which may be cast electronically during virtual meetings

To Read if Adopted: ARTICLE V - OFFICERS

Section 1. The officers shall be a president, a vice president, and a secretary-treasurer, all of whom shall be elected biennially by ballot which may be cast electronically during virtual meetings in the same year (even numbered years) that the officers of GFWC/Ohio Federation of Women's Clubs are elected. They shall serve for two (2) years or until their successors are elected. If there is but one nominee for each office, the election may be by voice.

Rationale: Allow for elections to occur during virtual meetings

Current: ARTICLE V - OFFICERS

b) The vice president shall serve as membership chairman. She shall advise the Executive Committee of the members of GFWC/Ohio Federation of Women's Clubs who are eligible to join THE PIONEER WORKERS. She shall invite those eligible to attend the next annual meeting and include luncheon registration and dues information.

Proposed Change: In Second sentence after “include” **Delete:** luncheon

To Read if Adopted: ARTICLE V - OFFICERS

b) The vice president shall serve as membership chairman. She shall advise the Executive Committee of the members of GFWC/Ohio Federation of Women's Clubs who are eligible to join THE PIONEER WORKERS. She shall invite those eligible to attend the next annual meeting and include registration and dues information

Rationale: Current Practice

Current: ARTICLE VI - MEETINGS

Section 1. An annual meeting shall be held each year preceding or during the GFWC/Ohio Federation of Women's Clubs annual convention, at which time annual reports of officers and committees shall be given and any awards that are appropriate shall be presented.

Proposed Change: Section 1. First Sentence, Delete after “year”: preceding or during the GFWC/Ohio Federation of Women's Clubs annual convention **Insert:** “in conjunction with the GFWC Ohio Annual Meeting (Convention)

To Read if Adopted: ARTICLE VI - MEETINGS

Section 1. An annual meeting shall be held each in conjunction with the GFWC Ohio Annual Meeting (Convention), at which time annual reports of officers and committees shall be given and any awards that are appropriate shall be presented.

Rationale: To allow flexibility of scheduling the annual meeting

Current: ARTICLE X - AMENDMENT OF BYLAWS

These bylaws may be amended at any regular meeting of the organization by a two-thirds vote, provided that the amendment has been mailed to each member with the notice of the annual meeting.

Proposed Change: Delete “mailed to” Insert after “been”: published not less than 6 weeks prior to the meeting by mailed/mailed to address on record for

To Read if Adopted: ARTICLE X - AMENDMENT OF BYLAWS

These bylaws may be amended at any regular meeting of the organization by a two-thirds vote, provided that the amendment has been published not less than 6 weeks prior to the meeting by mailed/mailed to address on record for each member with the notice of the annual meeting.

Rationale: Improve Communication with members for potential Bylaw changes

REPORT OF THE HISTORIAN by Barbara D. Whitaker

With the need for social distancing, work of the Historian this administration has been to continue work on gathering Buckeye Magazines for inclusion in bound copies for The Ohioana Library. Slowly, but surely, old copies are being found to try to complete the missing materials. In addition, research was conducted to determine how Ohio Federation responded to the pandemic of 1918 for help in determining a course of action for the pandemic of 2020. The answer was that convention was canceled but the organization had had the foresight in 1917 to place into the bylaws a group of officers and club presidents to act on behalf of the whole. Over the years, the purpose of this group was forgotten, and it was felt no longer needed, and was removed from the bylaws in the 1970's or early 1980's. This group still would have been too large for the current governor's size limitation on gatherings. So, looking to history, the conference call convention of 2020 was held. With a precedent set, examples from the past emergencies to guide us, and modern technology, this year a virtual convention will be held.

REPORT OF THE RESOLUTIONS COMMITTEE JANUARY 2021

As the report of the 2018-2020 committee was not addressed at the 2020 teleconferenced GFWC Ohio convention, this report comprises both those resolutions that would have been considered in 2020 and those for consideration in 2021.

The following resolutions were reviewed and are recommended to remain unchanged:

4-04 INTERNET SEXUAL PREDATORS

2-09 HARASSMENT, INTIMIDATION, HAZING, AND BULLYING

The following resolution is recommended to be rescinded:

1-05 MEDICAL MALPRACTICE INSURANCE REFORM. The work of the resolution has been completed with the passage of the Ohio Medical Malpractice Improvement Act, effective, March 20, 2019.

The following resolutions are recommended for amendment:

Resolution 3-04 GYNECOLOGIC CANCER (Reaffirmed 2008, 2013; Reviewed 2017)

WHEREAS, **according** to the National Cancer Institute, ovarian cancer is the ~~fifth~~ **thirteenth** most common cause of cancer death in females and the ~~leading~~ **second most common** cause of death from gynecologic malignancies; and endometrial cancer is the fourth most common cause of gynecologic cancer; **and highest among women ages 65-74;**

WHEREAS, Greater than fifty percent of gynecologic cancers in the body cavity are detected in the advanced stage and therefore have a higher mortality, and there currently are no cost-effective screening tests for gynecologic cancers within the body cavity; therefore

RESOLVED, That members of GFWC/Ohio Federation of Women's Clubs are encouraged to have annual bi-manual pelvic examinations and annual PAP smears (or as recommended by their health care provider), know the early warning signs of gynecologic cancers, have ultrasound and CA125 tests as indicated; and further

RESOLVED, That the members support education, legislation and medical research to advance the early detection and treatment of gynecologic cancer.

Justification: Updating to current statistics

Resolution 1-16 CURSIVE HANDWRITING

Whereas, Cursive writing is becoming a lost art form, one which stimulates brain synchronicity, assists in overcoming motor challenges and increases intelligence and language fluency; Whereas, Cursive writing allows for artistic expression through the interplay between hand, eye, mind, pen, and paper.

Whereas, Cursive writing connects students to the past by giving them the ability to read historical documents that were written in cursive, not only public documents but family history; Whereas, learning cursive writing reinforces learning by giving students another opportunity to fully comprehend the alphabet and a clearer understanding of how letters are formed, improving their print writing art as well by training fine motor skills; and

Whereas, the Ohio Board of Education adopted a resolution in February, 2015, reiterating its support for the instruction of cursive, noting benefits in developing fine motor skills and improving literacy.

Whereas, Students with learning disabilities are given another option that can decrease dyslexic tendencies as in **the printing of** several letters **which** resemble another, such as b and d

Resolved, That the GFWC Ohio Federation of Women's Clubs urges its member clubs to

- **Continue to encourage school systems and teachers to include cursive as part of the curriculum in their classrooms as early as possible and continuing through 5th grade and beyond, if warranted.**
-
- Support teaching the art of cursive writing to children beginning at age 7 or 8 and to those who were not previously taught the art of cursive handwriting.
- Assist with the teaching of the art in schools and libraries.
- Support **further** legislation to keep cursive handwriting as part of educational curriculum, such as House Bill 146.

Justification:

Gov. Kasich signed HB 58 on December 19, 2018. This new law requires the Ohio Department of Education (ODE) to include supplemental instructional materials on cursive handwriting in the English language arts model curriculum for grades K–5. These materials must be included by July 1, 2019, and will be updated periodically. Use of the supplemental instructional materials is not mandatory. R.C. 3301.0726. The need for further instruction in Cursive should be available to teachers who were not introduced to its instruction while in college as well as students who might have fallen into non-cursive instruction in elementary school. Classes can also be offered as an elective in schools, universities and as community education opportunities.

-Resolution 1-09 PROTECTION OF OUR OCEANS

Resolution 1-09 PROTECTION OF OUR OCEANS (Reviewed 2016)

WHEREAS, Oceans cover more than 2/3 of the Earth's surface, play a critical role in the global water and carbon cycles and in regulating climate, sustain a large part of the Earth's biodiversity, provide an important source of food and other natural products, act as a frontier for scientific exploration, are critical to national and economic security and provide a vital means of transportation;

WHEREAS; The oceans are susceptible to change as direct and indirect results of human

activities, and such changes can significantly impact the ability of the oceans to provide the benefits to the Earth which affect global climate patterns, ecosystem productivity and health, biodiversity, environmental quality, availability of energy, vulnerability to natural hazards and transportation safety and efficiency;

WHEREAS, Human pressure on ocean resources is drastically increasing due to chemical, nutrient and biological pollution, over fishing and use of destructive fishing practices, habitat damage and ocean acidification; and

WHEREAS, While there is a plethora of laws, government agencies and programs dealing with ocean resources activities they are poorly coordinated and do not constitute a unified and comprehensive public policy towards the oceans and it is the continuing mission of the Federal Government to create foster and maintain conditions, incentives and programs that will further ensure the sustainable and effective conservation, management and protection of the oceans in order to fulfill the responsibility of each generation as trustee in protecting such resources and ensuring that such resources will be available to meet the needs of future generations; therefore

RESOLVED, That the GFWC/Ohio Federation of Women's Clubs supports effective water conservation and management efforts at the local, state and federal levels, the development of a National Ocean Policy that unifies and coordinates ocean preservation efforts, specifically the National Ocean Policy and Leadership Act of 2008 (S. 3314) and H.R. 21;

RESOLVED, that in 2010 the National Policy for the Stewardship of the Ocean, Coasts and Great Lakes was established and created a National Ocean Council (NOC) to address conservation, economic activity, user conflict, and sustainable use of the ocean, our coasts and the Great Lakes; and further

RESOLVED, That the GFWC/Ohio Federation of Women's Clubs urges it members to practice and advocate water conservation and support the Ocean and Great Lakes Conservation Trust Fund by encouraging the use of a special postage stamps to afford a convenient way to support efforts to protect, maintain and restore marine ecosystems **when available**.

Justification:

President Trump has introduced on June 19, 2018 H.R 6300 to the 115th Congress rescinding some of the protection of the oceans as outlined in the original act under Presidents Clinton and Obama in favor of military and business uses of them. The National Ocean Policy and Leadership Act Of 2008 and National Policy for the Stewardship of the Ocean, Coasts and Great Lakes along with the National Ocean Council (NOC) will be greatly affected by this new House Rule. As the Resolution stands now it is still current. Postage stamps have been printed for the Great Lakes Dunes and Bio-luminescent Marine Life although these are not a result of H.R. 6300, but can still be used to raise awareness for the Great Lakes and our Marine Ecosystems.

The following new resolution is presented for adoption:

VAPING AND YOUTH

WHEREAS, The National Institutes of Health, a part of the U.S. Department of Health and Human Services, has found that vaping (use of electronic cigarettes, also known as JUULing) has risen in teenagers and may be driving an increase in nicotine use;

WHEREAS, The vapor may contain nicotine (the addictive drug in tobacco), flavoring, and chemicals and may contain marijuana, hash oil, or other substances;

WHEREAS, Exposure to nicotine during youth can lead to addiction and cause long-term harm to brain development and the vapor can also contain toxins (including ones that cause cancer) and tiny particles that are harmful when breathed in;

WHEREAS, the results of the study suggest that vaping is leading youth into nicotine use and nicotine addiction, not away from it and that teens are attracted to the marketable technology and flavorings seen in vaping devices;

WHEREAS, JUUL is a brand of e-cigarette that is shaped like a USB flash drive and the Center for Disease Control (CDC) found that approximately two-thirds of JUUL users aged 15 – 24 do not know that JUUL always contains nicotine; and

WHEREAS, federal and state officials have reported thousands of cases and dozens of deaths related to a newly identified lung disease that the CDC has named EVALI (the acronym stands for e-cigarette or vaping product use-associated lung injury);

WHEREAS, as of October 19, 2019, the sale of e-cigarettes to those under 21 is prohibited, youth still obtain the products; therefore

Resolved, that GFWC/Ohio Federation of Women's Clubs members encourages parents to talk openly and freely about vaping—with the caveat that they provide accurate information in age-appropriate language,

Resolved, that GFWC/Ohio Federations of Women's Clubs members continue to support legislation restricting advertising and sale of e-cigarettes and vapor products either in store or online to those over 21; and

Resolved, that GFWC/Ohio Federation of Women's Clubs members encourage restriction of e-cigarettes from all public venues.
